Exhibit Statement: The Sea Ranch Chapel Foundation is sponsoring a non-juried show open to all Mendonoma Artists. The purpose of the exhibit is to showcase outstanding visual art without regard to the type of media. The exhibit is a celebration of the Chapel's 30th Birthday. The show will be looking for art that focuses on the Chapel and the gift that it is to our community. The exhibit will feature work that can be representative, but also seeks to encourage artist's designs that reflect the feelings The Sea Ranch Chapel invokes. It can be an image of the chapel or it may be art that goes above and beyond representational art to recognize the unique form of the chapel. Artists are encouraged to visit the chapel to see and feel this sacred space, its colors, textures, shapes and forms in nature. Two and three dimensional art will be exhibited.

1. A Gualala Arts Registration fee is \$5.00 per entry. Up to three entries allowed/person. A \$10 donation **to The Sea Ranch Chapel Foundation** (Optional) would be most appreciated. See item #9.
2. This show will NOT be juried, but it will be judged and moderate prizes may be awarded. Awards will be done by People's Choice ballots, for 1st, 2nd and 3rd place.
3. Please fill out an Entry Form for EACH piece. Turn in the top portion to Gualala Arts, with entry fee by the 3/08/15 deadline. When delivering the art, attach the Entry Label portion securely to each piece. Keep the Artist Receipt for your personal record of what you are exhibiting.

4. The Entry Form provides basic information for the exhibit "Title Card" which is created by Gualala Arts. A "Title Card" will be displayed beside each piece. The information will include the unique Tracking Number, Artist's name, Title, Media and the Selling Price. It is essential that this information is correct, since this information is used to track sales and send checks to artists.
5. For this exhibit, artists are encouraged to use all media, 2-D and 3-D. The work submitted should be no more than 5 years old and may have been exhibited publically on the Mendonoma coast in past.
6. Gualala Arts will retain 30% commission on all sales of entries (and multiples) made during the course of the exhibit.
7. Please ensure all artwork is professionally prepared for hanging or display (no saw-tooth hangers, no "clip frames", etc.). Gualala Arts is not liable for any art work or installation, at any point in the process.
8. Make Entry Fee checks payable to Gualala Arts and mailed to Gualala Arts Center, C/O Chapel Art Challenge, PO 244, Gualala, CA, 95445.
9. Donations to the Chapel Foundation should be sent to PO Box 259. The Sea Ranch, 95497. The Sea Ranch Chapel is a (501) (3)(C) foundation and all gifts are deductible. A gift receipt will be sent. Gualala Arts is NOT processing the donations.
10. The Exhibit Opening Reception will be 04/10/15, 5:00 to 7:00 p.m. Please try to attend and celebrate the Chapel's 30th Birthday.
